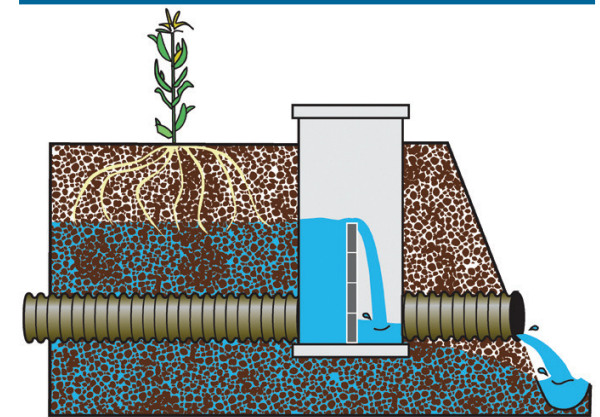

Technical Service Provider (TSP)

What is it and why is it important?

The 2002 Farm Bill expanded the capacity of USDA conservation programs to protect the nation's natural resources on private and tribal lands. In order to better serve agricultural producers, the 2002 Farm Bill also encouraged USDA to use technical service providers to increase the technical assistance available to help landowners meet their conservation goals.

Technical service providers are certified individuals, private businesses, non profit organizations or public agencies that are qualified to help meet the conservation technical assistance needs of America's farmers and ranchers.

Under the 2008 Farm Bill, provisions were implemented to compensate qualified landowners by providing financial and technical assistance to help pay for TSP Services.
